












Pursuant to the European data protection law (Art. 13, European Regulation 2016/679), the User acknowledges that Prequel-Genetics is committed to processing the User's personal data in accordance with the principles of fairness, lawfulness, transparency, and the protection of confidentiality. Therefore, the User is informed that:

	A. CATEGORIES OF DATA: The personal data subject to processing may include your identifying data, personal details, contact information, and health-related data.
	B. DATA CONTROLLER: The Data Controller is Prequel-Genetics (CY) LTD, with its registered office located within the European territory at Strovolou 77, Strovolos Center, Flat 301, 2018 Strovolos, Nicosia, Cyprus. Email: legal@prequel-nipt.com Operational offices: Rome - Torino
	C. SOURCE OF PERSONAL DATA: The personal data held by the Data Controller are collected directly from the data subject.
	D. PURPOSE OF DATA PROCESSING AND LEGAL BASIS: The processing of your personal data, collected and stored in connection with the completion of this form, is based on your consent and is carried out for the following purposes: to enable registration on the website, to contact you, to respond to your requests, and to proceed with the booking as requested by you.
	E. DATA RECIPIENTS: Within the limits relevant to the purposes of the processing indicated, your data may be communicated, if necessary, to other parties involved in the processing activities, both internal and external to the Data Controller, such as employees and associates, partners, consulting firms, and private companies. Your data will not be disclosed in any way.
	F. TRANSFER OF DATA TO THIRD COUNTRIES: The data collected are not subject to transfer to third countries outside the European Economic Area (EEA).
	G. DATA RETENTION PERIOD: The collected data will be retained for a period no longer than necessary to achieve the purposes for which they are processed ("storage limitation principle", Art. 5, GDPR), or in accordance with the deadlines established by legal obligations. The relevance and obsolescence of the retained data, in relation to the purposes for which they were collected, are periodically reviewed.
	H. DATA SUBJECT'S RIGHTS: The data subject has the right at any time to request from the Data Controller access to their data, rectification or erasure of such data, restriction of processing, or to object to the processing. The data subject also has the right to request data portability and to withdraw consent to processing, as well as to exercise any other rights provided by the GDPR, by simply contacting the Data Controller. The data subject may also lodge a complaint with a supervisory authority.
	I. OBLIGATION TO PROVIDE DATA: We inform you that the provision of data is optional for some fields, and mandatory for others (marked with an asterisk). The failure to provide the mandatory data may result in the inability to execute the requested service.
	J.
